#### RECOMMENDED ACTION AND JUSTIFICATION:

Discussion and direction relative to a Resolution establishing an Amnesty Program for Yosemite West.

Based upon direction from the Board of Supervisors, County Counsel has prepared a draft Resolution for your review regarding establishing an Amnesty Program for Yosemite West. Pursuant to Ordinance No. 934 (copy attached) and the Cease and Desist Order of the Regional Water Quality Control Board (RWQCB) of November 15, 2004 certain processes must be undertaken in order to ensure compliance with both the Ordinance and the Cease and Desist Order of the RWQCB.

This draft Resolution has been reviewed by the County Administrative Officer, Building Director, Planning Director, Public Works Director, and the Treasurer/Tax Collector. Their comments and requested revisions have been incorporated into the draft.

Also, attached is a copy of the Public Works Director's written notification to the RWQCB with respect to this action. As the amnesty is only for existing connections to the system it does not appear that any technical report would be required by the RWQCB Cease and Desist Order of November 15, 2004 (at page 11, item 7). Should such a report be required for any permit paragraph 3 of the Resolution addresses that issue.

The earliest effective date for the Amnesty Program would be 60 days from the date of the Public Works Director's written notification to the RWQCB. The purpose of this agenda item is to request the Board's direction with respect to bringing this matter back before the Board for action should it be the Board's decision to proceed in that manner.

## A RESOLUTION ESTABLISHING AN AMNESTY PROGRAM FOR YOSEMITE WEST

WHEREAS, the Board of Supervisors enacted Ordinance No. 934 prohibiting the hook-ups to the Yosemite West Maintenance District's water and sewer services, and

**WHEREAS**, the Board of Supervisors prohibited issuance of permits for new bed and breakfasts or transient occupancy facilities as well as permits for new construction or conversion of single family dwellings; and

**WHEREAS**, the Board of Supervisors prohibited acceptance of any application for processing which required a new sewer or water hook-up or caused any flow increase into the District's system; and

WHEREAS, repairs have been made to the system such that it can handle existing flows and there are individuals desiring to bring themselves into compliance with Mariposa County rules and regulations for permitting and conversion of facilities; and

WHEREAS, section three item G of Ordinance 934 permits the Board of Supervisors to allow issuance of permits under certain conditions.

NOW, THEREFORE BE IT RESOLVED by the Mariposa County Board of Supervisors, a political subdivision of the State of California, does hereby resolve as follows:

- 1. That if the Public Works Director can verify that the structures that existed at the time Ordinance No. 933 was enacted and uses will not increase the flow into the current wastewater treatment system at Yosemite West and the RWQCB does not object to such permits, and the Mariposa County Health Officer concurs permits may be issued as set forth below.
- 2. That for three months from the date of this Resolution the County of Mariposa will accept and process applications for bed and breakfast and transient occupancy permits, and applications for building permits for constructed or converted buildings which are otherwise in compliance with County Code if the Public Works Director can verify that they are currently discharging to the existing treatment system in Yosemite West and will not increase the flow or otherwise threaten the integrity of the system; and
- 3. That any applicant for any permits, including but not limited to, building permits, bed and breakfast permits, and transient rental permits, shall, prior to the issuance of the permits, submit all plans for approval, where applicable, and pay all appropriate fees and penalties. Inspections will be conducted after permit issuance based upon the Uniform Building Codes. Any applicant will be required to furnish or pay for any technical or other reports required by the California Regional Water Quality Control Board pursuant to its order of November 15, 2005; and
  - 4. That any applicant shall pay an additional amnesty processing fee of \$100 for each permit; and



- 5. For all construction or conversions of residencies for rental or other purposes for which a building permit is sought to bring the structure into compliance with County Code, the owner or party requesting the permit shall pay staff costs for additional inspections that are beyond those normally allowed under the permit being applied for; and
- 6. All permits shall be processed in accordance with all codes and policies in effect at the time the application is accepted and the permit is issued; and
- 7. Any person who has been utilizing the property for rental purposes shall provide to the satisfaction of the County Tax Collector documentation to support any past transiernt occupancy taxes owed and any and all penalties normally assessed for such delinquent taxes, all of which shall be paid prior to the issuance of a bed and breakfast or transient occupancy permit; and
- 8. This Amnesty Program shall expire of its own accord at 5:00 p.m. on \_\_\_ after which time no additional applications will be accepted under this Resolution. All such applications must be at the County office wherein the application is normally filed no later than the date specified hereinabove. Mailed or otherwise transmitted applications which have not arrived in the County office by the specified date and time will not be accepted. h. Submit certification from a California registered civil engineer that the modified WWTF is capable of providing adequate treatment and disposal capacity for 15-year projected wastewater flows, design seasonal precipitation, and ancillary inflow and infiltration.

- 6. Submit written progress reports by the 1<sup>st</sup> day of the second month following the end of each calendar quarter beginning with the third quarter of 2003. Progress reports must summarize all actions taken to comply with this CDO during the calendar quarter, and discuss whether uncompleted tasks remain on schedule for completion by the deadlines specified in the CDO.
- 7. Submit a written technical report within 30 days granting any exemption to the connection ban, and written notification at least 60 days preceding any proposed actions by the Discharger to remove or modify the ban.

All technical reports required herein that involve planning, investigation, evaluation, or design, or other work requiring interpretation and proper application of engineering or geologic sciences, shall be (a) prepared by or under the direction of persons registered to practice in California pursuant to California Business and Professions Code, sections 6735, 7835, and 7835.1; and (b) subject to written Executive Officer Approval. To demonstrate compliance with Title 16, CCR, sections 4.15 and 3065, all technical reports must contain a statement of the qualifications of the responsible registered professional(s). As required by these laws, completed technical reports must bear the signature(s) and seal(s) of the registered professional(s) in a manner such that all work can be clearly attributed to the professional responsible for the work.

If, in the opinion of the Executive Officer, the Discharger violates this Order, the Executive Officer may refer the matter to the Attorney General for judicial enforcement or, alternately issue a formal complaint for Administrative Civil Liability.

Mariposa County Ordinance No. <u>934</u>

AN ORDINANCE RESTRICTING WATER AND/OR SEWER HOOK-UPS
AND THE ISSUANCE OF BUILDING AND OTHER PERMITS FOR ANY PROPERTY
WITHIN THE YOSEMITE WEST MAINTENANCE DISTRICT
AND RESCINDING URGENCY ORDINANCE NO. 933

The Board of Supervisors of the County of Mariposa, a political subdavision of the State of California, does hereby ordain as follows:

#### SECTION I: FINDINGS AND DECLARATION

On or about May 15, 1998, the leachfield which services the sewer system for the Yosemite West Maintenance District (District) suffered a total failure, causing treated and untreated sewage to flow from the leachfield to open ground. In the opinion of the County Health Officer and the Director of Public Works, the failure has resulted from an extremely wet winter and spring causing water infiltration into the sewer system, together with the possibility of reaching the normal capacity of the sewer system.

Emergency measures are being taken to help reduce the discharge, however, because of the topography of the location of the leachfield and the extremely saturated ground, it is currently impossible to get equipment to the location.

It is the intent of the Board of Supervisors of the County of Mariposa, upon the recommendation of the District Board of Directors, the appropriate permitting authority, and the Public Works Director to take action to prohibit additional hook-ups and to prohibit the issuance of permits which could in any way add to the flow int o the District sewer system, until such time as the appropriate permitting authority determines that the system can accommodate increased flow and the Board of Supervisors takes formal action by Resolution or Ordinance allowing hook-ups or issuance of permits.

#### SECTION II: PURPOSE

The purpose of this Ordinance is to prohibit water and/or sewer knock-ups and prohibiting the issuance of permits for property within the District which could in any way add to the flow into the District sewer systems, until adequate repairs are made or inflow has decreased to a satisfactory level as determined by the Board upon recommendation of staff





#### SECTION V: PENALTY

Violation of any provision of this Ordinance shall constitute a misdemeshor and shall be punishable under Chapter 1.20, the General Penalty provisions, of the Mariposa County Code.

### SECTION VI: RESCISSION OF URGENCY ORDINANCE No. 933

Upon the effective date of this Ordinance, Urgency Ordinance No. 933 shall be rescinded in its entirety.

In accordance with the notification requirements of Section 7 of Cease and Desist Order No. R5-2003-0070 for Yosemite West Maintenance District WWTF, Mariposa County, the Mariposa County Board of Supervisors are considering passage of a resolution establishing an amnesty program for the Yosemite West Subdivision located in Mariposa County. The purpose of this amnesty program is to correct longstanding building permit and transient occupancy rental violations. The amnesty program will only correct permitting issues for existing facilities, it will not allow for the construction of any new facilities. The amnesty program will not result in an increase in wastewater flows to the Yosemite West Wastewater Treatment Facility.
