CDF arranges with U.S. Forest Service fire prevention officers from Sierra National Forest to conduct an **Annual Fire Hazard Clearance Inspection** in Yosemite West to evaluate property owners' compliance with defensible space regulations. For details, please visit www.yosemitewest.org/100ft.htm.) The fire prevention team completes a written checklist for residents noting any conditions that require the property owners' attention and may issue citations for noncompliance.

The Annual Fire Hazard Clearance Deadline, which is in early to mid July, will be posted on the USFS signboard along the entrance road to Yosemite West.
