D. Newsletter

E. Fire Safety

Chipping program is likely to be funded by a grant again this year. Still no burn pile. The ownership issues seem ignored by the county and not making progress.

F. Chipping

Kelly will get dates from John Mock for this year's chipping, and Bert volunteered to ensure that there's flagging on all the chipping piles.

IV. Old Business

Kelly provided an update on the county audit process.

Recycle bins were great last year, and it's getting close to time to reopen them again. We'll call Total Waste to arrange having them opened soon.

V. New Business

Water issues. County did maintenance on water lines below the mailboxes. Requires boil order until test results come back clean. Tenants were upset that they weren't notified in some cases, and the posted paper wasn't timely in other areas
